MUSIC TUITION 2016-17

Dear Parent/ Carer,

Your child has expressed an interest in learning a musical instrument/singing lessons.

The options available are:

- Guitar
- Drums
- Piano
- Singing

Each lesson lasts for 20 minutes and will take place during class time. Students are therefore expected to catch up on any work missed during the lesson. There will be two students in each lesson. If you wish to have one-to-one tuition, please get in touch with Mr Gourlay (agourlay@corbytechnicalschool.org) to discuss this. You will have to pay double the costs below.

The cost of for tuition is listed below. This is payable termly in advance with the first payments made by **September 19**th **2016.** Payments can be made through Wise Pay. This will guarantee 30 lessons during the course of the academic year.

- Term 1 = £36 Payment by September 19th 2016
- Term 2 = £36 Payment by October 9th 2016
- Term $3 = \pm 36$ Payment by December $18^{th} 2016$
- Term $4 = \pm 36$ Payment by February $26^{th} 2017$
- Term 5 = \pm 36 Payment by May 6th 2017

There will be musical instruments available in school for students to practice outside of lessons. You may wish to consider purchasing an instrument for your child to practice at home. Should you need advice on suitable instruments please contact Mr Gourlay at school.

Please read the accompanying Terms and Conditions and then sign and date the contract before returning it to Mrs Forster in the school office, places will be allocated on a first come, first served basis.

Instrumental Tuition – Terms and Conditions

The following terms and conditions provide the basis on which the instrumental contract is agreed to. Please read the following before signing the contract.

1) The contract is ongoing. It may be terminated by giving a term's written notice.

Terms will follow the NMPAT academic year as follows:

- Autumn Term 3rd September 18th December
- Spring Term 5th January 24th March
- Summer Term 12th April 20th July
- 2) Non-payment of Tuition Fees will result in your son/daughters music tuition being withdrawn.
- 3) Lessons take place during normal class time. Any student wishing to have lessons must make every effort to catch up with any work missed. It is the student's own responsibility to do this.
- 4) If your son/daughter is loaned an instrument for the period of the lessons you will be required to arrange insurance for the instrument.
- 5) Students will be required to provide their own music books. These books will be specified by the member of staff providing the lessons. The school cannot make photocopies of music and hence is unable to supply music to students directly.
- 6) Failure to attend lessons on a consistent basis may result in the withdrawal of the offer of lessons by the school. The place will then be allocated to another student. This period would normally be three unattended lessons in any one term without good reason.
- 7) If the student is absent from the school on the day of lessons they should notify the designated member of staff as soon as possible.
- 8) Notification of any exam entry will be sent to you prior to any entry actually being made. Your consent for this will be requested first, before any exam entry is made by the school.
- 9) A reasonable amount of practice will be required during the week in order to maximise the benefits of these lessons. Support from parents with this practice will ensure better progress for your son / daughter.
